## MINUTES OF THE BOARD MEETING AIA VERMONT Tuesday, February 10, 2009 Barre

#### Committee Reports

- 1. Program
  - a. Michael will be making a presentation on "Modern Architecture" at the Contois Auditorium in Burlington's City Hall on March 19<sup>th</sup> at 7:00 p.m. This will be the kick-off for the series on modern architecture followed by a panel discussion in May-June and a lecture by Glenn Andres in September.
  - b. Michael will have all the information on his presentation by next Monday.
    - 1) It was suggested that announcements of all programs be made to the AIA Vermont members a month before the event, followed up by reminders.
    - 2) Announcements should be sent to Steven Clark so that he can post them on the Web Site as soon as possible.
- 2. Communications
  - a. Harry Hunt e-mailed the minutes of the Communication Committee meeting on Tuesday, January 27, 2009.
- 3. Public Policy
  - a. Key issue at this time is The Economic Recovery Act. The Senate has removed all funding for K-12 educational facilities, higher education and the Greening of Federal Buildings.
    - 1) John proposed meetings with elected Officials and working with the Building Professionals Group.
    - 2) Members should be encouraged to e-mail Vermont Senators and Congressman.
      - a) **Michael** will compose an announcement to the AIA Vermont members on the Economic Recovery Act with links for their e-mails.
  - b. It was suggested that a person be appointed by the Board to be in full pursuit of legislative affairs
  - c. Public Officials should be invited to the R/UDAT in Newport
  - d. There will be a Public Hearing on the Fire Safety Codes on February 25<sup>th</sup> at The Fire Marshall's Office; there will be a follow-up meeting in March for public comments.
    - 1) It was suggested that AIA Vermont schedule a meeting of the Professional Building Group prior to the March meeting.
      - a) Michael suggested that the Governor should be involved with code issues and that Tayt Brooks be contacted for strategies.
      - b) Stephen will get the original letter of the ICC codes for the meeting.
      - c) **John** will let Hanne know what date the meeting should be held.
- 4. Long Range Planning
  - a. Guy is preparing a Manual for new Board Members. This manual should be a multiuse tool for organizing what AIA Vermont does and wants to do.
    - 1) Guy will send a draft to the Board for comments and input.

### Grassroots Report

- 1. Overview: Hill Visits
  - a. John reported that the Economic Recovery Act was the focus of the AIA Vermont group's meetings with Congressional Staff people. The staffs were encouraged to consider "Shovel Worthy" rather than "Shovel Ready" projects.
- 2. John, Daniel and Harry met with the AIA representative of R/UDAT, Joel Mills, to discuss the plans for the Newport, VT R/UDAT.
  - a. Harry sent the Board an e-mal with the facts about this R/UDAT.
  - b. AIA Vermont members should be encouraged to attend some of the R/UDAT events scheduled for March 18<sup>th</sup>-23<sup>rd</sup>.

- 3. The joint meeting with AIA New Hampshire will be held in September at the AVA Gallery & Art Center in Lebanon, NH.
- 4. Emerging Professionals: Stephen has a list of potential sites for building tours.
  - a. Mo Gagnon, AIA is the YAF (Young Architects Forum) Regional Liaison and will be invited to a Board meeting to discuss an Emerging Professionals program.

- 6. Lauren thought that an Opening Reception for the AIA Vermont Travelling Design Awards Exhibition at Burlington's City Hall next year would not be necessary.
