1014.11 Interior stairway enclosures:

Interior exit stairways shall be enclosed with five seperation assemblies having a fire resistance rating of not less than 2 hours except that such stairways in occupancies in Use Group A, B, E, F, H-4, I, M, R, or S which connect less than four stories shall be enclosed with fire seperating assemblies having a fireresistance rating of not less than 1 hour. An exit stairway enclosure shall not be used for any purpose other than means of egress. Openings in exit enclosures, other than unexposed exterior openings, shall be limited to those necessary for exist access to the enclosure from normally occopied spaces and for egress from the enclosure.

This fall, on October 23rd, AIA Vermont and Efficiency Vermont will present a six o'clock evening tour and program centered around the newly completed Northern Power Systems building located in Waitsfield, Vermont.

Northern Power Systems is noted as an international leader in providing alternative systems for power with a strong basis in utilizing renewable energy sources; whether it be by cogeneration in a metropolitan area or stand alone systems in remote areas such as the Andes and Antarctica. Therefore, as part of the architectural and engineering programming for its own facility, they included the requirement that sustainable and energy efficient systems be utilized throughout the project.

In addition to the tour, representatives of the Owner, Bast and Rood as the Architects, GWR as the Engineers and Efficiency Vermont will present a program, in a panel type format, which will explain not only their individual roles but also how those roles have interacted to the benefit of the overall project from concept to completion.
