midd day: from hardy holtzman to kieran timberlake, college to tell all nov. 9

Middlebury College is impossible to ignore, architecturally speaking. Its granite, spire-studded campus is the very quintessence of Vermont collegiate architecture, yet in recent years the school has mostly steered clear of local architects. Because of its large endowment and niche near the top of America's list of elite undergraduate institutions. Middlebury has the means and the motivation to commission spectacular buildings - yet, in the eyes of some, several of the newer College buildings have been spectacular failures. And three major new campus projects, by Gwathmey Siegel, Tai Soo Kim and Kieran Timberlake, are poised to make new and indelible marks on the Champlain Valley 'skyline.'

It's one thing to be Vermont's biggest architectural client, with all the controversy that status entails. It's quite another to engage the state's architects and architecture students in an open and wide-ranging dialogue about the College's recent architectural choices. Remarkably, Middlebury has chosen to do just that, inviting Vermont's AIA chapter to convene at the campus on Saturday, November 9 for an event entitled "Middlebury Day for Architects: Assessing Recent Design."

Kicking off this all-day event will be a presentation and discussion led by Professor Glenn Andres of the College's History of Art and Architecture Department. Andres, who teaches architectural history and urbanism - resources" to improving and expanding the school's at Middlebury, with courses on modern and post-modern design, is a key player when it comes to the school's recent architectural projects. He serves as a faculty liaison to the College's facilities planning group, and chairs of the planning and building committees for the new Gwathmey Siegel-designed College library now under construction.

Following lunch, there will be opportunities to experience Middlebury's recent architectural choices firsthand. College officials will lead tours of the Payette science building, the newly completed Ross Commons complex designed by Tai Soo Kim, the Center for the Arts, The Grille (a highly popular student hangout created by Freeman French Freeman, the only local participants in recent College projects), and (depending on interest) Coffrin Hall, the Edward Larrabee Barnes-designed residential complex that, in 1986, began Middlebury's current and ongoing blizzard of new architecture. Assisting Andres in leading these site visits will be Tom McGinn of the College's facilities planning group and Professor Pieter Broucke, Andres' colleague from the school's art and architectural history department.
