	4.	<p>Vote on changes to bylaws that will reflect more contemporary methodologies while ensuring regulatory compliance with the State of Vermont and AIA National. Changes/modifications/insertions are underlined. See below.</p> <p>5.11 A notice of each meeting of this Chapter, stating the date, time and place where the meeting will be held, shall be given by the Secretary, personally or by mail or <u>email</u>, to each member entitled to vote at the meeting.</p> <p>5.12 At any meeting of this Chapter, <u>five</u> percent of the membership entitled to vote shall constitute a quorum for the transaction of any business.</p> <p>5.14 <u>Remote Attendance of Meetings. Board members and Chapter members may attend meetings remotely.</u></p> <p>5.21 Every decision at a Chapter meeting shall be by a majority vote of those members in good standing who are present <u>in person or remotely</u>, and voting, unless otherwise required by law or these bylaws.</p> <p>6.31 The officers of this Chapter shall be the President, Vice President/President-Elect, and Secretary/Treasurer (<u>if this position is held by one person</u>), or <u>Secretary and Treasurer (if these are separately appointed or elected positions.)</u></p> <p>A motion was made to accept the above proposed bylaw changes.
